The [Institute for Advanced Studies \(IHS\)](#) is an independent, non-profit research institute in Vienna (Austria). It brings together high-level expertise from various disciplines (economics, sociology, political science, and others) to address fundamental economic and social problems and policy choices.

IHS welcomes Expressions of Interest by postdoctoral researchers of any nationality, to apply jointly with an IHS host supervisor to the Marie Skłodowska-Curie Postdoctoral Fellowship Call 2022.

The [Marie Skłodowska-Curie Postdoctoral Fellowship](#) is a prestigious European funding scheme that supports mobility, career development, and training within and beyond Europe, and offers 12-24 months' highly competitive salary and research funds. The goal of the fellowship is to enhance the creative and innovative potential of experienced researchers, wishing to diversify their individual competence in terms of skill acquisition through advanced training, international and intersectoral mobility. EU Postdoctoral Fellowships or Global Postdoctoral Fellowships applications are open from 13 April 2022 to 14 September 2022.

IHS welcomes Expressions of Interest in the following research areas:

- Electoral studies, legislative studies, EU governance
- Labor market and social policy
- Energy and climate policies and related socio-economic dimensions
- Regional and rural development and the sustainability transition
- Register-based research on educational careers
- Applied behavioral and experimental economics
- Health and long-term care policy, health services research
- Macroeconomic forecasting, macroeconomic policy, public finance
- Impact of techno-scientific innovations on contemporary and future societies

Eligibility criteria for Marie Skłodowska-Curie at a glance¹:

- **Research experience:** Doctoral Degree with a maximum of 8 years post-doctoral research experience. Non-research activities, career breaks and for nationals or long-term residence of EU Member States (MS) or Associated Countries (AC) years of research experience in a third country will not be considered in the above maximum.
- **Researchers wishing to reintegrate from a third country** must be either based in a third country at the call deadline or have moved directly to a MS/AC within the last 12 months before the call deadline. Supported researchers can be of any nationality.
- **Mobility rule:** At the time of the deadline for submission of proposals (= 14 September 2022) the researcher must not have worked or resided in Austria for more than 12 months within the past 3 years.
- **Funding for researchers:** The fellowship programme offers a generous living allowance, as well as a mobility allowance of EUR 600 per month, and a family allowance (if applicable) of EUR 500 per month.

Your Expression of Interest (EOI) should consist of **(1) a COVER LETTER, (2) your CV and (3) a max. 3-PAGE RESEARCH PROPOSAL SUMMARY.** Please submit your application in English to msca@ihs.ac.at – by **Sunday, 5 June 2022** at the latest. After a careful consideration by IHS senior researchers in the respective field, candidates with promising applications will be invited to prepare the full proposal together with their designated supervisor at IHS. Assistance with regards to proposal development and submission will also be provided by IHS.
