#### Methods and Data

The RG works mainly with quantitative data, statistical methods and macroeconomic models that are complemented by qualitative data, e.g. interviews with political actors.

► European Social Survey

Since 2013, the RG/Dr. Peter Grand is responsible for the ESS as the national coordinator for Austria. The survey is conducted every two years throughout Europe, with the last wave covering 20 countries. It focuses on citizens' opinions and values within the context of the substantial institutional and political changes within the nation state and the European integration project.

#### ► TaxLab

TaxLab, a computable general equilibrium model developed at the IHS since 2004, is used to analyse and quantify the macroeconomic impacts of policy reforms related to the labour market, the pension system and taxes. It covers Austria and 13 other countries of the European Union, either separately or together in a multi-country version.
